- ➤ Point of Information: Myron Starr will be submitting a cost estimate to paint a mural on the north side of the green building.
- b) Police Department Report
  - > Hayden Police Chief Marquez gave a written report to the Council Members.
  - ➤ Chief Marquez, Town of Winkelman Mayor Bracamonte and Town of Hayden Mayor Hetrick will be meeting with the Hayden-Winkelman Unified School Board on Tuesday, May 9, 2023 to discuss security. The Towns do not want any liability in the event of a school emergency. The three entities need to develop a joint emergency plan.
- c) Fire Department Report
  - > Mud Volleyball Tournament
    - The Fire Department wants to help raise money for Hayden's Football Program. They would like to use the existing pits and the concession stand at the Winkelman Flats Public Park. The tournament will be on June 10<sup>th</sup>.
    - Council Member Skillings made the motion to allow the Winkelman Fire Department to host a volleyball tournament and to use the concession stand with no charge. Council Member Bravo seconded the motion, and it carried unanimously.

- > Discussion and Possible Approval for a fence design for the fire station

    - Council Members reviewed the expense report. No comments were made.
  - ➤ Discussion and Possible Approval to increase overnight camping fees from \$10.00 per night to \$15.00 per night.

  - ➤ Point of Information: Wastewater Operator, Arthur Monterde, will be attending the Rural Wastewater Association of Arizona conference from May 23-25, 2023 in Tucson. He needs to keep his operator's license current.
  - > Discussion and Possible Approval to hire Wendy Gort, as a consultant, to work in the wastewater treatment plant.
    - Clerk Ruiz explained that that since Mr. Polk resigned, Mr. Monterde will be needing help in the wastewater treatment plant, due to limited staff.
    - Ms. Gort will be charging \$1,850.00 per month. She will be collecting samples, taking them to the lab and filing reports with ADEQ.
    - After much discussion, Council Member Bravo made the motion to accept the contract and hire Wendy Gort for \$1,850.00 per month in the wastewater treatment plant. Council Member Skillings seconded it, and the motion passed unanimously.
