Sgt. Heaslip stated that fortunately no one else in the large dance crowd was injured. Hayden Police Department have three videos they are reviewing. The incident is still under investigation; however, the victim is not cooperating. The suggestion is not to have any bands for next year during Easter. The bands brought an aggressive crowd.

- Mayor Bracamonte asked Sgt. Heaslip if his officers can patrol the Park, citing people driving ATVs. Sgt. Heaslip suggested purchasing signs for the Park, indicating speed limit and forbidding ATVs.
- c) Fire Department Report Council Members reviewed the written report. The department has responded to three fire calls and one medical call since the April 2022 Town Council Meeting.
- d) *Municipal Report* There were five (5) citations for the month of April 2022 from the Hayden Police Department and one (1) from the Winkelman Animal Control Officer.
- e) Animal Control Report There was no report for this department.
- f) Parks & Recreation Report
 - Consideration to enclose the large ramada area at the Winkelman Flats Public Park with fencing Public Works Supervisor Arthur Monterde submitted a memorandum, indicating what materials are needed to enclose the ramada area. No costs were included. Mayor Bracamonte estimated it would cost \$1,100.00 just for the fencing and said that the summer youth workers would help install the fence. Mr. Monterde's memorandum also indicated that the ramada needs a new roof. Since it is not on the agenda, it will be considered for the June 2022 meeting. Vice-Mayor Hinojos made the motion to purchase materials and to install fencing around the ramada area. Council Member Skillings seconded the motion, and it carried unanimously.
