She explained that this was the final Public Hearing that was advertised in the Copper Basin News to give the General Public an opportunity to decide how to spend approximately \$225,000.00 in Community Block Development Grant (CDBG) Funds. The choices were renovating the Green Building into a community center, paving streets and adding speed bumps, sidewalks, streetlights, forestry restroom and playground equipment. After some discussion, the Town Council chose paving streets and adding speed bumps.

There will be another mud volleyball tournament fundraiser for the football team on Saturday, July 29, 2023. The Council had previously given permission to host this.
 - 8.3b Discussion and Possible Approval to pay hotel and per diem to send Firefighters to Fire School Chief Weber obtained six (6) scholarships to cover the cost of registration for classes for Fire School in Mesa, AZ. The Town will be reimbursed after the firefighters complete the classes. Chief Weber said they will rent an Airbnb to offset costs.
