8.2 Police Department Report

Chief Marquez gave the July 2023 report to the Council. Winkelman had sixty-two calls. Hayden Police Department and Winkelman Fire Department attended a Public Safety Integration Training regarding active shooter response. Chief Marquez said that on August 26th the police department will be having "Pop with a Cop". They will be giving popsicles, water and hosting free swimming. The Police Department was given one million dollars from the State, but it will be distributed in four phases of \$250,000.00. They purchased five new vehicles. They will auction off the old vehicles in the Winter. Chief Marquez is trying to implement a program. In the event of an emergency at the Hayden-Winkelman USD, someone can push a button on an app that sends a signal to Kearny Dispatch. First Responders will be able to see the situation live. The school has most of the cameras installed. The delay is with Kearny Dispatch because of their building issues.

8.3 Fire Department Report

- 8.3a Old Business: Discussion Regarding Selling the Small Fire Truck Fire Chief Weber withdrew his request to sell the small fire truck.
- 8.3b Discussion and Possible Approval of Purchasing a three thousand gallon Surplus Water Tender for \$1,000.00

Chief Weber said Three Points Fire Department offered to sell their water truck because they received grants for new equipment. No commercial drivers license is needed to drive the vehicle. The truck needs an air valve replaced, so the truck will need to be towed. The purchase price is \$100.00. The towing cost is \$900.00. Three Points Fire Department needs approval from their Council.

8.5 Animal Control Report

Animal Control Officer Flores said there was a picture posted on Facebook regarding an emaciated dog in Winkelman. After investigating, Mr. Flores found out it was a female dog with a litter of puppies. At that particular property there had been two female dogs, and each had a litter, three weeks apart. Officer Flores contacted Winkelman Town Hall about a warrant, but he later made contact with the owner. The owner had agreed to surrender the female dog and her puppies to Officer Flores. However, before Officer Flores could take the dogs, someone entered the owner's property and stole the dogs. After that, the owner was upset and refused to surrender the dogs to Officer Flores. They later found out who had taken the dogs. The owner did not press charges and let the person, who entered his property, keep all but one of the puppies and the mother dog. Hayden Police Officer Gomez made contact with the owner. The female dog did not look as bad as the picture. Officer Flores said she was now probably gaining weight because she did not have to nurse all of her puppies. Officer Flores said the situation was fine, but if this proceeds further, then he will have to build a case on animal cruelty and have the dog examined. What made the situation difficult was the person who interfered by stealing the dogs.

8.6a Discussion and Possible Approval of a Bid from 2K Tree and Industrial Services for \$9,000.00 to trim trees at the Winkelman Flats Public Park Arena for safety reasons Mayor Bracamonte explained that the large eucalyptus trees by the arena have dry and heavy limbs that need to be cut. Vice-Mayor Hinojos made the motion to accept the bid for \$9,000.00 from 2K Tree and Industrial Services to trim the branches from the eucalyptus trees by the arena.
