- a) Ms. Vicky Peacey, Acting Project Director for Resolution Mine, will provide an update on the Copper Mine Project.
 - Mr. Dave Richins appeared on behalf of Resolution Copper Mine. He said the Environmental Impact Study (EIS) should be published in 2023. There will be no surface impacts for ten (10) years. He said Resolution is using the same water over and over, and they have banked acres of water.
 - Resolution Copper has been a good neighbor to the surrounding communities by issuing scholarships, sponsoring the Hayden-Winkelman Little League, being a part of the Copper Basin Chamber of Commerce and donating toys for Winkelman's Christmas Event.
 - Mayor Bracamonte asked about the tailings in Dripping Springs. Mr. Richins said not much is being done, but Resolution has purchased most of the private land in Dripping Springs. There will be as slurry line twenty (20) miles long.
 - There is a rumor that a company in China purchased Resolution Copper. Mr. Richins denied this.

9. Sale of Town Vehicles - Open Sealed Bids

- a) 1968 International Water Truck
 - Mayor Bracamonte opened the only sealed bid that was submitted for the 1968 International Water Truck. It was submitted by Pete Gallego for \$525.00.
- b) 2016 Trail-Wagon (ATV)
 - Mayor Bracamonte opened the two (2) sealed bids that were submitted for the 2016 Trail-Wagon ATV. One was from Sam Polk for \$725.00. The other was from Susan Middaugh for \$827.00. Per Town Attorney Flake, it is the discretion of the Town Council to select the bidder. The Council decided to award the bid to purchase the Trail-Wagon ATV to Sam Polk. - c) Fire Department Report
 - Fire Chief Weber will provide information on the extra CDBG funding available and purchases made There was an extra \$16,866.00 left from the grant. They purchased hoses, nozzles, tools and other items. The Wildland Fire Truck is complete, and they do not have to pull items from the other fire trucks.
 - Jose Hernandez is the Assistant Fire Chief, effective December 12, 2022.
 - There are currently sixteen (16) firefighters. They also started a Junior Firefighter Program and have three (3) members. They are all seniors.
 - Jose Hernandez will be conducting a CPR-First Aid training.
 - A battery for the car is needed. They will purchase one at Eddie's Tires.
- d) *Municipal Report* There were no citations for the month of November 2022, and \$356.00 was collected by the Court. Council Members reviewed the written report.
- e) Animal Control Report
 - Animal Control Officer Flores said two (2) cages have been loaned out. He has had seven (7) calls regarding dogs at large, but when he arrives on scene, the dogs are gone. He has received calls about Victoria "Toya" Scott's dogs running at large. Council Member Rutledge said her dogs are eating cats. Officer Flores said he has not seen evidence of this.
 - J.D. Romero still has his dog, despite it attacking another dog on Copper Hill Lane. Hayden Police Department took the report.
- f) Parks & Recreation Report Discuss what official action can be enforced by the Town to ban certain people from our Public Park
 - Per Town Attorney Flake, do not use the word "ban". Just ask the people to leave the Park and keep asking them to leave. Staff has the authorization to do this. People can be charged with Trespassing if they do not leave.
 - The Town will be purchasing six (6) trees at \$40.00 each to plant inside the Ramada.
 - Clerk Ruiz said that Kearny Police Department has been dropping off homeless people at the Park. Mayor Bracamonte said he will speak to the Kearny Mayor about this.
- g) Sanitation Division Report
 - No delinquent residents have made a payment in December.
- h) Street Division
 - Council Member Skillings mentioned making Giffin Avenue into a one-way road.
 Mayor Bracamonte said he will talk to the people this will directly affect and place it on the January 2023 agenda.
- i) Wastewater Treatment Plant
 - There have been problems with the Bacti being elevated. This has been occurring because the sewer plant backs up, causing a plug.
- 14. <u>Call to the Public</u> Mr. Fred Ruiz asked why there is no crosswalk on Highway 177 and Randall Avenue. Council informed him that the highway is ADOT's property.
